### The Institute

The Biomedical Research Institute of Lleida Fundació Dr. Pifarré (IRBLleida) was established with the aim of creating synergies between basic, clinical and epidemiological research, making biomedical research a key driver to improve current clinical practice. IRBLleida covers a chain of translational research, from basic research, aimed at understanding the physiological and pathological mechanisms of the human body, to research that studies the behavior of diseases in large population groups.

The Biomedical Research Institute of Lleida ([IRBLleida](#)) was founded in 2004 through a cooperation agreement between the University of Lleida (UdL) and the Catalan Healthcare system. IRBLleida integrates research groups of the faculties of Medicine and Nursing and Physiotherapy of the UdL. On the other hand, we incorporate research groups from:

1. The Catalan Health Institute ([ICS](#)) both at the hospital level (Arnau de Vilanova University Hospital - [HUAV](#)) and the primary healthcare of [Lleida](#) and the [Alt Pirineu-Aran Health Region](#),
2. The healthcare provider [Gestió de Serveis Sanitaris \(GSS; Santa María University Hospital - HUSM, Pallars Regional Hospital](#) and [Mental Health](#), among others).

IRBLleida has been a CERCA institute since 2013, and as such is organized according to a model of good governance and operation that ensures efficiency, management flexibility, talent recruitment and promotion, strategic planning and executive capacity. It is also one of the 34 Spanish Health Research Institute ([IIS](#)) recognized by the [Carlos III Health Institute](#) and the Government of the Generalitat, as established by Law 16/2003, of 28 May, on the cohesion and quality of the national health system.

These requirements must be met at the beginning of participation in the program.

**Context and tasks to be developed:**

The selected person will join the Institute of Biomedical Research of Lleida (IRBLleida) to fill a position of Data Analyst, corresponding to those provided for in Royal Decree Law 32/2021, of 28 December, on urgent measures for labour reform, the guarantee of employment stability and the transformation of the labour market. This Royal Decree-Law has highlighted the need to incorporate temporary positions occupied by temporary staff into the structural workforce because the functions assigned to them form part of the ordinary and habitual activity, given that they have exceeded their strictly temporary dimension or have lost their own autonomy and substantive nature. For this reason, it is necessary to promote the structural dimensioning of these posts, which can no longer be considered temporary and be filled under a temporary employment regime, in accordance with the new regulatory framework for temporary contracts established in the Workers' Statute.

The stabilisation of this post was approved in the Agreement of the Board of Trustees of IRBLleida on 3 June 2022 and published in the Official Journal of the Generalitat de Catalunya No. 8763 of 30 September 2022.

The selected person will perform the following tasks:

- Transferring clinical information to databases of medium-high complexity level.
- Optimisation and automation of processes for processing large amounts of data.
- Creation, debugging and restructuring of databases.

- Data quality controls.
- Developing new analytical tools for data validation.
- Carrying out related research projects.
- Extending and improving ETL.
- Exploration of new concepts to be mapped.
- Collaboration with general tasks assigned to you.
- Attending meetings with national and international teams working on analysis plans and programmes to be executed.
